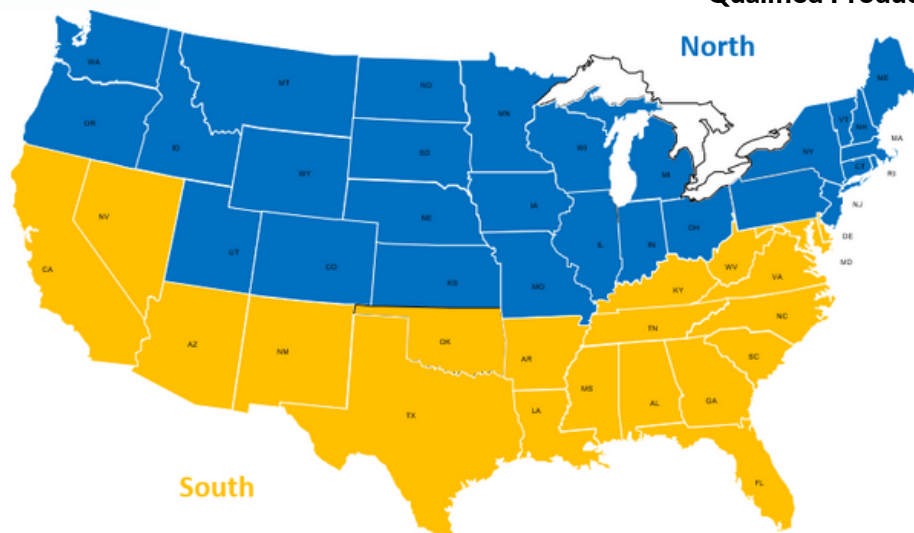

## Energy Efficient Home Improvement (25C) Tax Credit

- This tax credit is effective for products purchased and installed between January 1, 2023, and December 31, 2032, and can be claimed annually.
- The tax credit states any homeowner who installs a new heat pump on or after January 1, 2023, may be eligible for a tax credit of up to 30% of the total cost they paid to purchase and install the new unit, up to \$2,000.
- The heat pump must meet or exceed the highest efficiency tier (not including any advanced tier) established by the Consortium for Energy Efficiency (CEE). \*\*

\*\*Efforts are underway to simplify the efficiency performance qualifications. Updates will be posted as they become available.
